Behavior Specialists are wanting FLSA-Exempt status rather than FLSA status (Cliff Tillman/ Baltazar Villarreal) Baltazar Villarreal discussed job duties of a Behavior Specialist and states that the vote in favor of going exempt was about 90%. Mona Mosk recommends that Recreation Therapists revisit this issue as well.
3.
